are used as raw material, semi finished parts or intentionally added to its products in quantity greater than 0.1% .

Arco-Cavi Group srl declares that its products are exempt of any substance subjected to be registered in the SCIP database.

Arco-Cavi Group srl declares that its articles and products are compliant to the **EU Regulation No 2019/1021 on Persistent Organic Pollutants (POP)** of 20/06/2019.

Moreover, **Arco-Cavi Group srl** declares that all the supplied products don't contain **bisphenol A** in quantity greater than 0.02% , compliant with **Regulation (EU) 2016/2235 of December 12, 2016 amending Annex XVII to Regulation (EC) No 1907/2006** as regards **bisphenol A**, that will come into force on January 2, 2020.

Arco-Cavi Group srl declares the compliant with Commission **Regulation No. 1272/2013 that came into force on June 20, 2016**, in particular the restriction of more than 1 mg/kg (0.0001 percent by weight of the part considered) of the following PAHs: Benzo[a]pyrene, Benzo[e]pyrene, Benzo[a]anthracene, Chrysene, Benzo[b]fluoranthene, Benzo[j]fluoranthene, Benzo[k]fluoranthene and Bibenzo[a,h]anthracene, Benzo[def]chrysene for the part that come into direct as well as prolonged or short-term repetitive contact with the human skin or the oral cavity under normal or reasonably foreseeable conditions of use.

After the ECHA's proposal to reduce the use of microplastics added intentionally to the products on the EU/EEA market in order to reduce the environmental release, **Arco-Cavi Group srl** declares that its products don't contain microplastics added intentionally for a concentration greater than 0,01% by weight.

In reference to **Directive 2011/65/EU**, which came into force on January 3, 2013 concerning the restriction of the use of certain **hazardous substances in electrical and electronic equipment (RoHS 2)**, recast of the previous Directive **2002/95/CE (RoHS)**, **Arco-Cavi Group srl**, declares that:

- Low voltage cable shall fall within RoHS as a result of the inclusion of the new category 11, that will come into force from July 22, 2019.
